Ramp Progress – Scott Shipman

- Scott is looking for volunteers to assist in building a ramp. However, with Scott only being here on the weekends, there may be scheduling conflicts.
- Pat Martin mentioned after the meeting there may be someone available with a Bob Cat that could provide a grade to the water. Further investigation is required.
- Liability insurance for MPACA to have water access was discussed and we currently have a \$1 million policy (held through Williams Agency and written by Atlantic Casualty Insurance Co. of Goldsboro, NC). It is suggested by our lawyer to raise the coverage to \$2 million. The new MPACA board will need to pursue additional coverage. Our current policy expiration date is July 15th.
- A point was raised by Tony Boyd-Heron concerning any liability considerations if we build our own ramp without a licensed contractor. Need for further investigation.
